You are advised to send intimations within the prescribed time to the Central Government of the amounts of each foreign contribution received by you, the source and the manner in which the foreign contribution was utilised as per the provisions of the FC(R) Act, 1976 and the rules framed thereunder. The association is required to furnish the return even when the particulars are 'NIL'. The Bank Account mentioned in your application should be exclusively for receiving the foreign contribution and no other amount should be credited to this account. Any change with regard to the name of the association, its address, registration aims and objects etc. should be promptly intimated to the undersigned and in case of any of the above changes, fresh registration of the association under the provisions of the Act, will be necessary.

3. In case the association brings out any publication (registered under PRB Act, 1867) and acted as correspondent, registered newspaper at a later stage thereby attracting provisions of the Section 4(1)(b) of the FC(R) Act 1976, the fact should be reported to the Ministry immediately.

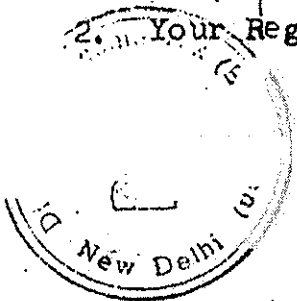

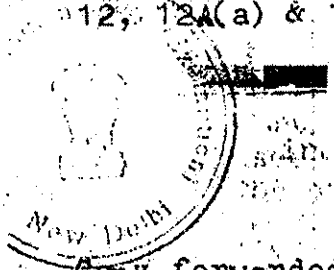

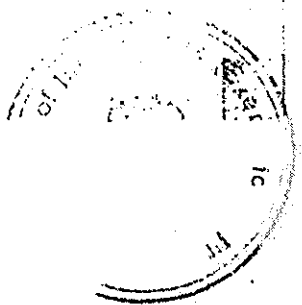
